

## OFFICIAL CONTEST RULES

**NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN ONLY TO SPICEWORKS REGISTERED COMMUNITY USERS WHO ARE LEGAL RESIDENTS BELGIUM, CANADA, DENMARK, GERMANY, SWITZERLAND, THE UNITED KINGDOM AND THE UNITED STATES WHO HAVE REACHED THE AGE OF MAJORITY IN THEIR COUNTRY, STATE OR PROVINCE OF RESIDENCE AS OF DATE OF ENTRY. THE PROMOTION IS INTENDED FOR LOCATIONS WHERE CONTESTS ARE NOT PROHIBITED BY LAW. **1. CONTEST PERIOD:** The entry period for the "Devolutions *What's the Strangest End User Request You've Ever Received*" Contest (the "**Contest**") begins on July 15, 2019 at 1:00 a.m. EST and ends on August 15, 2019 at 11:59 p.m. EST (the "**Contest Period**"). By participating in the Contest, each entrant unconditionally accepts and agrees to comply with and abide by these Official Contest Rules and the decisions of Devolutions inc. (the "**Sponsor**"), which shall be final and binding in all respects.

**2. ELIGIBILITY:** This Contest is open only to Spiceworks Registered Community Users who are legal residents of Belgium, Canada, Denmark, Germany, Switzerland, the United Kingdom and the United States (excluding residents of locations where contests are restricted or not permitted), and who have reached the age of majority in their Country, State or Province of residence as of date of entry. A Spiceworks Registered Community User ("**User**") is a person who has joined the Spiceworks community at <https://community.spiceworks.com/>. There is no cost or future obligation to become a Spiceworks Registered Community User and there is no purchase required. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by the potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond as directed within five (5) days following the first notification attempt, or if a prize or prize notification is returned as unclaimed or undeliverable to any potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected in a random drawing from among the remaining eligible entries.
